

2. 目的

證券持有人的個人資料可被採用及以任何方式持 有,處理及/或保存,以作以下列用途:

- 處理 閣下的申請及退款支票(如適用)、核 實是否符合本申請表格及招股説明書載列的 條款和申請程序以及公佈香港發售股份的分 配結果;
- 遵守香港及其他地區的適用法律及法規;
- 以證券持有人(包括香港結算代理人(如適用))的名義登記新發行證券或轉讓或受讓證券;
- 存置或更新本行證券持有人的名册;
- 核實證券持有人的身份;
- 確定本行證券持有人的受益權利,例如股息、供股和紅股等;
- 分發本行及其附屬公司的通訊;
